The Federal Election Commission has called to our attention an error on our FEC report that we have confirmed and are correcting by amended report.

NCMA PAC contributed \$5,000 to the Ortiz for Congress Committee on April 29, 2010. (As you may recall, this contribution was delayed because our planned event for Mr. Ortiz on March 19, 2010 had to be cancelled due to the health care vote.) Unfortunately, the cover letter enclosing the check and our subsequent FEC report inadvertently attributed the contribution to his primary election cycle, which concluded on March 2, 2010.

We are therefore amending our FEC report to count the contribution properly as against the general election cycle. Our contributions to his primary and general election cycles are within the allowed limits.

NCMA PAC regrets the error.
