-Schedule A supporting Line 15 of your reports discloses offsets to operating expenditures from apparent joint fundraising committees (see attached) which appear to be related to expenses paid by your committee for a joint fundraising effort. Please amend your report to clarify which disbursements these offsets are associated with.


