The Fairfax County Democratic Committee is an all volunteer committee with no paid staff of any kind. No other entities pay compensation for their employees to work for the committee either part time or full time. No payroll expenses are incurred. The committee maintains both Federal and non Federal accounts, and it has elected not to allocate its administrative expenses between accounts, so all administrative overhead expenses are paid 100 percent with Federal funds. The Committee does not engage in any fundraising on behalf of candidates for Federal office, so all of its reported fund raising expenses are party fund raising. This amendment is needed so that all 2008 reports are being filed with our new donor management software provided by NGP. The conversion to this new software in March 2008 corrupted accumulated expenses by line number in the later FEC monthly reports, created errors in classification of disbursement data imported from Quickbooks accounting software, and caused duplicate reporting of some of our fund raising expenses. Duplicate transactions have been removed and reported only once. Corrections were made to other disbursements as needed. These corrections should not be needed for reports filed in the future.
