In May 2021 the Cummins Inc. individual responsible for transferring the funds from Cummins Inc. to Cummins PAC left the company and there was not transition documentation. As a result, a wire sent on May 26 in the amount of \$5102 was a duplicate of the payment for the May 14 payroll which was funded on May 19. Since the May 14 and May 28 payrolls were in the same amount, but deposited on different dates, the second deposit was assumed to be a different payroll file. A deposit on June 7 in the amount of \$5400.46 funded the May 28 payroll totaling \$5102 but was over \$298.46. It did not become apparent until the reconciliation of the June activity that the May 26 deposit was a duplicate deposit of the May 14 payroll. An audit was conducted to make confirm the duplicate deposit on May 26 and the overage on June 7. This was confirmed on July 13, 2021. A check was written from the PAC to Cummins Inc. on 7/19/2021 to refund the amount of the duplicate deposit.
