

Our contributions to your campaign total \$1,500, paid by check # 774, dated June 11, 2008, in the amount of 1,000, and check # 778, dated August 23, 2008, in the amount of \$500. Copies of the checks are attached.

Obviously we were not aware we were violating Federal Election statutes. We registered with the FEC with the desire and in the belief that we were in compliance. The law is enormously more complex than we knew and our simple records system was not adequate to provide the rigorous information the law requires.

We’re sorry. We’re sorry we messed up. We’re sorry your campaign was unsuccessful. We’re sorry it’s so difficult to support those we believe in to be our elected representatives. And we’re sorry we must ask for a return of the monies we gave you. Please communicate with me at the above address.




