The Associated Builders and Contractors PAC is in receipt of your letter dated October 8, 2008 questioning whether the payment for McCain bumper stickers reported on line 21b of the PAC's September Monthly report constituted either a public communication or voter drive that should have been reported either on line 23 or 24. These bumper stickers were prepared by the PAC for the Association's restricted class. As such, they did not constitute public communications pursuant to 11 C.F.R. § 100.26 or allocable voter drive activity pursuant to 11 C.F.R. § 106.6(b)(2)(i). Instead, these bumper stickers are permitted pursuant to 11 C.F.R. § 114.3 as a communication with the restricted class. Further, as stated by the Commission in Advisory Opinion 2000-03, "If an SSF of a corporation finances activity that is permissible for the corporation to finance itself, then in essence the SSF is making those payments on behalf of the corporation, or as part of the corporation. This is tantamount to payments by the corporation." Further, that opinion states that such payments should be reported as "other disbursements." Thus, the PAC is amending the report to move the payment to line 29 as indicated in Advisory Opinion 2000-03. Thank you for bringing this matter to our attention.
