This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-The total listed on Line 23, Column B of the Detailed Summary Page appears to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Line 23, Column B total. Please amend your report and any subsequent reports that may be affected by this correction.

-Your calculations for Lines 23, Column B through 31, Column B appear to be incorrect. FEC calculations disclose this amount to be \$19,306. Please provide the corrected totals on the Detailed Summary Page.

-The Summary Page discloses \$225.52 on Line 6(c), Column A, but the Detailed Summary Page shows the Line 19, Column A total to be \$525.52. These figures should be the same. Please amend your report accordingly.


-Your calculations for Line 8 appear to be incorrect. Cash-on-hand at the close of the current reporting period should always equal the closing calendar year-to-date cash-on-hand amount. Please provide the corrected total on the Summary Page.
