Those who do not disclose this information receive a thank you letter with a postpaid reply envelope requesting this information once again.

Our Schedule A contains all information in our possession concerning the full name, mailing address, occupation and name of employer for all individuals who contribute \$200 in a calendar year.

As you will note, our Schedule A reports for 1995 contain full information on about 40 out of 64 individuals who gave \$200 or more. This is a drastic improvement over our reports for 1994 and prior years. The improvement is directly attributable to the increased efforts at obtaining this information mandated by the Commission.
