Dear Mr. Evans:

Enclosed are revised FEC Form 3X for both reporting periods of calendar year 95 (1/1/95 to 6/30/95 and 7/1/95 to 12/31/95). Upon receipt of your letter I directed our new accountant to review both submissions and these revisions resulted.

There is no change to the total amount of contributions or disbursements made by the PAC in 1995. There has been a revision to the 7/1/95-12/31/95 report to eliminate some double reporting of contributions that were reported in the preceding period. These were deposits in transit at the close of June, and were included again on the 7/1/95-12/31/95 report as "contributions being researched" since our previous bookkeeper was unable to reconcile the bank statements to the FEC reports.

Additionally, the previous reports did not include the small amount of interest earned and bank charges incurred on the 1/1/95 to 6/30/95 report and had calculations errors on the 7/1/95 to 12/31/95 report.

My apologies for the confusion these errors created. I am confident I now have a competent bookkeeper who will preclude future occurrences.
