This letter is in response to your request for additional information regarding the year end report for the Cleveland Stonewall Democrats PAC. My name is Jeffrey Zelmer, I am the Deputy PAC Treasurer. Mr. John Farina, The PAC Treasurer at the time the report in question was issued, has stepped down so I am responding to your request.

The Cleveland Stonewall Democrats PAC is a non-connected committee that chooses to support both federal and non-federal candidates. To achieve this, The Cleveland Stonewall Democrats PAC has set up up one federal account that supports both federal and non-federal candidates and reports all activity to the FEC. The account is under the CSD PAC name with National City Bank in Cleveland. In the last quarter of 2007 all the disbursements and receipts were for non-federal candidates.

I believe the information submitted in the year end report was partially filed on the incorrect forms (H4). It is my understanding that, based on the information I listed above, the report should have been filed on a Schedule A for Receipts and a Schedule B for Disbursements. And in addition, since no receipts for the year exceeded \$200 per contributor, the receipts did not need to be itemized.

Attached you will find the amended report using Schedule B. If my understanding on how to file this information based upon the CSD PAC setup is not correct, please accept my apologies and forward me the instruction on how to correct my mistake. Thank you for your assistance in this matter.
