

Over the course of July 1st through July 31st, 2008, Dickstein Shapiro LLP provided \$269.82 in legal and accounting services to the PAC. This reflects general accounting, work on internal reconcilement of PAC transactions, and preparation of the June monthly report to the Federal Election Commission. The services were provided on various dates by Katie Phillips (\$168.98), Monica Prahl (\$13.52), Jeffrey Campbell (\$51.66) and Chris LeGrand (\$35.66).

This memo text refers to the in-kind contribution of \$33.80 from Dickstein Shapiro LLP for administrative costs, which is reflected on lines 11a and 21b. These in-kind services provided by the firm represent very limited staff time, overhead, supplies, and postage associated with functions, such as raising funds for the PAC. No separate staff or office space is available for PAC administrative functions and almost all communication is via the Internet. Thus, resulting administrative costs are minimal.
