This letter is to inform you that as of May 8, 2002, the Commission has not received your response to our request for additional information, dated April 17, 2002. This notice requests information essential to full public disclosure of your federal election campaign finances. To ensure compliance with the provisions of the Federal Election Campaign Act (the Act), please respond to this request (copy enclosed).

An adequate response must be received at the Commission by May 29, 2002. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended. This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-On Schedule A supporting Line 11(a)(i), you disclose memo entries with no corresponding receipt included in the line total. A memo entry is used to disclose additional information about an itemized transaction that is included in the total receipts or disbursements for the current report or previous report. Please amend your report to clarify these entries.

-Schedule B supporting Line 23 of your report discloses contributions to DASHPAC, Democratic Leader's Victory Fund 2000, and America's Foundation; however, you have disclosed "Thomas Daschle SD-D-Senate", "Richard A. Gephardt (MO-3)", and "Rick Santorum (PA-R-Senate)" in the purpose of disbursement fields. Please clarify whether these were earmarked contributions made by your committee through DASHPAC, Democratic Leader's Victory Fund 2000, and America's Foundation committees to these candidates, or if you made the contributions to the political committees exercising no direction or control over how the funds were to be used. If the latter is the case, please do not include the candidate's name in the purpose of disbursement field. Please amend your report to clarify the ultimate recipient of these contributions.

A response or amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter. Electronic filers must file amendments (to include statements).
