It also includes language informing donors that federal law requires the Committee to request such information from anyone who contributes more than \$200 annually. If a contribution is received without it, a written request for the information is mailed within 30 days, along with a pre-addressed return envelope. Any contributor information received as a result of the Committee's best efforts is reported to the Commission either in an amended report or on the next report it files.
