Disbursement of \$8,721.40 (Item C on Schedule B) to our connected organization (NCGA) in no way influenced a federal election or benefited specifically identified federal candidates. \$5,994 of it was reimbursement for overhead auction event decor incorrectly charged to and paid by NCGA to The Meeting Manager company for our fundraising auction event which occurred March 3, 2010. The remaining \$2,72-7.40 was to reimburse NCGA for overhead auction credit card fees incurred on its bank account as a result of credit card purchases and admission fees at the event. These bills were received by CornP-AC after the March FEC filing deadline. Regarding Item B on Schedule B for \$27,260.31 paid to Marriott Business Services, no portion of these expenditures was made on behalf of any specifically identified candidates or to influence any federal election. These charges were solely for overhead food and beverage expenses at our fundraising auction event March 3, 2010. This bill was received after the March FEC filing deadline.
