MEMORANDUM OF AGREEMENT
 BETWEEN
 ASH GROVE CEMENT COMPANY

 LOCAL LODGE D 229
 SPRINGFIELD, MO

RE: JOB BUMPING
 SECTIONS 10.6 and 10.11

During the 1998 labor negotiations the parties reached an understanding, concerning the revised and negotiated Sections 10.6 and 10.11 of the labor agreement, that jobs which normally require a training period which exceeds thirty (30) work days are (a) the First Class positions of Maintenance (Bracket 12), Garage Repairman (Bracket 12), Powderman (Bracket 12), Electrician (Bracket 12 and Journeyman - Bracket 13), Machinist (Bracket 13) and full time Kiln Operator (Bracket 13) and (b) Electrician 2nd Class (Bracket 9). As such, employees cannot bump into the preceding jobs if their job is eliminated or if they become incapacitated (1) unless they have previously held such bid classifications at the plant or, (2) even if they have previously held such bid classifications at the plant, unless they can perform the essential functions of the positions, with or without accommodation but without additional training beyond the agreed to thirty (30) day work period. As always, employees requesting to bump will be considered for any position in accordance with the Section 10.1 provisions governing the filling of vacancies.
