
Dear Ms. Stilla

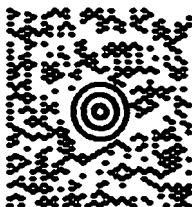

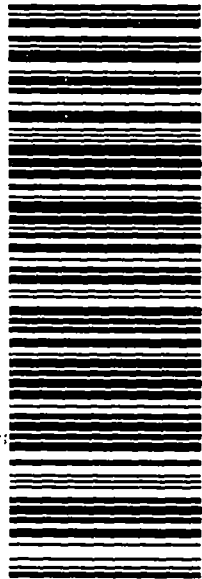
