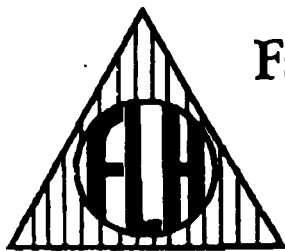

Dear Ms. Ioffe:

I am writing in response to your recent phone inquiry regarding the Fannie Lou Hamer Political Action Committee's (Tax I.D. #) Federal Election Commission (FEC) filings.

As of this writing, reports for years 2004 through 2007 have been filed. Delays in filing have been a result of familial and personal setbacks that affected our Treasurers' ability to complete the required training, report composition and subsequent filings in a timely manner.

Consequently, in April 2008 we retained the services of a certified public accountant, Greg Terrell and Company, to prepare our filings. Our engagement with Greg Terrell and Company requested that they complete our Federal Filings and submit them for all outstanding quarters through the end of 2007. Our treasurer of record was Edwin Washington, and it was his intention to complete the 2008 federal filings and submit them using the template that Greg Terrell and company completed. Suddenly and unexpectedly, he lost his job here in Michigan accepted employment out of state. Thus, he was unable to complete the filings prior to his departure.

As a result, we requested and have retained the services of George Crenshaw of Tax Masters to complete all outstanding Federal Filing requirements by March 13, 2009. I have requested that Greg Terrell and Company provide the data file and hard copies used to complete our Federal Filing requirements so that information can be given to Mr. Crenshaw. Please confirm that the information submitted by Greg Terrell & Company was filed manually rather than electronically. We are not aware of the procedure for filing the documents electronically. Please point us to the electronic instructions for filing the quarterly submissions electronically.

We sincerely, ask your consideration in allowing us the opportunity to comply and become current with regard to our outstanding filings.
