This letter is to inform you that as of November 8, 2000, the Commission has not received your response to our request for additional information, dated October 18, 2000. This notice requests information essential to full public disclosure of your federal election campaign finances. To ensure compliance with the provisions of the Federal Election Campaign Act (the Act), please respond to this request (copy enclosed).

The Commission notes that some corrections were filed in the committee's Amended July Quarterly dated October 13, 2000. However, Lines 7(b), 7(c) of the Summary Page and Line 14 of the Detailed Summary Page still need to be corrected. An adequate response must be received at the Commission by November 29, 2000. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.


-Column A, Line 7(b) of the Summary Page should equal Column A, Line 14 of the Detailed Summary Page.

-Column B figures for the Summary and Detailed Summary Pages should equal the sum of the Column B figures on your previous report and the Column A figures on this report. Please file an amendment to your report to correct the Column B discrepancies for Line(s) 6(a), 6(c), 7(a), 7(b), 7(c), 11(a)(iii), 11(e), 14, 15, 16, 17, 21, 22 and all subsequent report(s) which may be affected by this correction. Note that Column B should reflect only the year-to-date totals for the calendar year 2000.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
