Dear Mr. Morse:

This letter is in response to the FEC's Request for Additional Information dated January 12, 2015. The Commission requested additional information on three items in the HSLDA Federal PAC's Amended 30-Day Post General Report. After a review of our records, we have amended our filing for the 30 Day Post-General Report and have filed a new Amended Report.

Here are our specific answers to the Commission's Request:

1. The HSLDA Federal PAC's 30-Day Post General Report Schedule B supporting Line 23 contributions showed that several in-kind contributions made on behalf of federal candidates for the 2014 general election were disbursed after Election Day. These contributions were incorrectly dated. All of our in-kind contributions took place in the days immediately before or on Election Day, but the bills were paid for after Election Day.

In our newly filed Amended 30-Day Post General Report, these in-kind contributions have been revised to reflect when the in-kind contribution was made on behalf of the candidate, rather than when the check was written from our PAC treasury funds.


