All of the services, with respect to PAC activities such as fundraising and decision making about contributions, that the NFL donated to the PAC for the period of January 1-31,2020 took place between January 6-30, 2020. The National Football League donated 8.0 hours of professional staff time (valued at approximately \$1697.45) this reporting period to ensure compliance with the Federal Election Campaign Act.
