Dear Ms. Thangavelu:

This letter responds to the three Requests for Additional Information sent over your signature on October 27, 2006 regarding inconsistencies in the DLPAC 4/20-26/06, 7/1-5/06, and 7/6-14/06 12 Day Pre-Primary Reports' opening and closing cash balances and Summary and Detailed Summary Page Column B entries. DLPAC filed the appropriate amended reports electronically on November 20, 2006.


Our internal records and unfiled FEC reports do not reflect the inconsistencies noted in your October 27 letters. We believe these inconsistencies are due to transmission errors in the electronic filing process. Your office has apprised DLPAC of similar inconsistencies in the past and we have resolved them over the telephone by demonstrating that the versions of our reports that produced inconsistent figures in the electronic filing process have recorded the cash balances and Column B entries correctly in our FECFile Data Files. In resolving these matters, we have worked with the FEC staff to clarify DLPAC reporting data, amend our reports, and diagnose the problem to aid the Commission's electronic filing process. From an excess of caution, we are responding to the October 27 letters in writing and enclosing hardcopies of the three reports at issue, in addition to the filing the three reports electronically.
