On this report, our 'cash on hand' at end for reporting period is recorded as \$3,908.16. According to our bank, our actual cash on hand at end of the reporting period was \$4,037.16. That amounts to a discrepancy of \$129. Here's what accounts for this discrepancy: 1) the \$94 check written to GVO on 10/24/06 (recorded in Disbursements) has yet to be cashed; 2) there is \$35 in Income (Receipts) that we can't account for. That is, we must've received a \$35 check that somehow didn't get recorded in our tracking system but which ended up in our bank account. So, \$94+\$35=\$129. We originally estimated that we'd pay Direct Advantage Marketing \$30,000 (\$10K for each of 3 targets: Santorum, Allen, & Pombo.) As it turned out, they weren't able to do as much work on our behalf as was originally planned. (We were still assessed the normal charge---they simply did less work than planned.) So, instead of \$30K, the expense through 11/27 was only \$15,342.60. We now only owe them an additional \$1,684.70--we just got this invoice, so this disbursement will show up on our next report. This is because we did not receive the invoice for this remaining \$1,684.70 until after 11/27/2006. Once THAT payment is made, our total payment to DAM will come to \$17,027.30.
