In response to your letter dated September 11, 2002, we have electronically filed an amendment to the July Monthly Report (6/1/02 - 6/30/02) and the August Monthly Report (7/1/02 - 7/31/02) to reflect the following changes:

- A contribution to Friends of Jim Maloney dated June 27, 2002, in the amount of \$2,000 for the 2002 Convention was an excessive contribution. The check was returned and voided July 24, 2002. We have electronically filed an amendment to the August Monthly Report to reflect this change as a negative entry on Schedule B, Line 23.
- A contribution to The Gephardt-In-Congress Committee dated June 27, 2002, in the amount of \$3,500 was not designated. We have electronically filed an amendment to the July Monthly Report to note the General 2002 designation on Schedule B, Line 23. This designation was provided to the committee when the contribution was made. It's omission from our report was an inadvertent mistake.
