Dear Ms. Della Rocco:

The Committee to Elect an Effective Valley Congressman provides this response to your December 4, 2012 letter regarding the 12 Day Pre-General Report for the period of 10/1/2012 to 10/17/2012. The Committee will be filing an amended report that addresses the vast majority of concerns outlined in your letter. This letter responds to each of your concerns, noting which are addressed in the amended report that will be filed shortly.

1. The totals in the amended report now add up correctly.
2. On the amended report, these items now contain amounts matching on Schedule D and Schedule E.
3. These items appear as a Memo Schedule E item on the amended report.
4. The Committee did not fail to file any 48 Hour Reports. The items on Schedule E identified in the attachment were not disseminated on the dates shown on Schedule E. Schedule E shows the date the invoices were paid. These communications were disseminated after the period included in the Pre-General Report and the appropriate disclosure was filed when the communications were disseminated. The amended report clarifies with a memo on Schedule E that the communications were not disseminated during the reporting period.
5. The software that the Committee is utilizing presently will not allow us to report an item on Schedule E if the item was not paid or invoiced during the reporting period. The Committee understands the FEC's concerns regarding the absence of these entries from Schedule E and is working with our software provider to address them. We timely filed the 48 Hour Reports for all expenditures disseminated during the period, and disclosed all payments on the prior Quarterly Report. We will amend our Pre-General Report again after we have been able to address these concerns with our software provider.
