In regards to your letter dated September 3, 2010, We have updated amended the discrepancy regarding beginning cash-on-hand and will amend subsequent reports to ensure accuracy going forward. In regards to item two in the Amended May Monthly Report, we learned in June that contribution data from our telemarketing vendor had not been accurately recorded for several months. This initially produced what appeared to be a negative balance on our reports. They have since corrected the data upload process resulting in an accurate accounting of the contributions received via our telemarketing program. The additional receipts of \$59,630.80 reflect that change.
