-On Schedule H4 supporting Line 21(a) of the Detailed Summary Page, you have failed to check the appropriate CATEGORY box for the payment(s) made to Mary Williams, Jacquelyn Savoy, and Jeffrey Globor. Please amend your report to disclose the appropriate category.

-Itemized disbursements must include a brief statement or description of why the disbursements were made. Please amend Schedule(s) H4 of your report to clarify the following description(s): "GOTV Workers (captain)" and "GOTV Workers". For further guidance regarding acceptable purposes of disbursements, please refer to 11 CFR §104.3(b)(3).


An adequate response must be received at the Commission by October 17, 2001. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. Requests for extensions of time in which to respond will not be considered. Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply with the provisions of
