The federal portion is calculated by checking all of the offices that appear on the general election ballot, and dividing the points for federal office by the total points for all offices. Please verify that your Schedule H1 adequately reflects the 1998 general election ballot. If necessary, please amend your report to include a corrected H1.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
