Dear Mr. Buckley:

Thank you for speaking with me about the Commission's requests contained in your two letters of July 26, 2011. You have identified expenditures reported by NH Citizens Alliance for Action in its Year-End report for which you seek clarification on the date of the subject independent political communications. You have also identified vendors listed in the October 16-17, 2010, 24-hour report that did not have physical addresses listed. NH Citizens Alliance for Action construes the Commission's requests as a housekeeping measure and is happy to hereby supplement its prior filing at the Commission's request.

Taking the second issue first, with regards to addresses for Facebook.com and Staples.com, these expenditures were of an online nature and were not made at a traditional "bricks and mortur" store. Nonetheless, NH Citizens Alliance for Action hereby supplements the October 17, 2010 24-hour report to reflect the following addresses of these corporations:

With respect to expenditures you have identified in your second letter, these expenses were administrative charges ancillary to the distribution of political flyers in the ten days prior to and including election day, with the vast bulk of the expenses serving as administrative charges in support of canvassing on election day itself,

November 3, 2010. The reported dates are the dates the administrative expenses were invoiced or paid; a number of bills for these administrative expenses did not come due until after the election. The communications supported by these independent expenditures (or contributions) were the subject of previous 24-hour reports on October 24, 2010, October 28, 2010, October 29, 2010, October 30, 2010, and November 1, 2010. In addition, some of the administrative expenses supported a previous round of flyers earlier in October that were the subject of several 24-hour reports as well as a comprehensive quarterly report for October 15, 2010. There were **no** independent political communications after the election.

NH Citizens Alliance for Action prides itself on transparency and a belief in clean elections and has strived to be very thorough in disclosing all independent expenditures connected to the 2010 election. Thank you for the chance to supplement the public record on NH Citizens Alliance for Action's participation in the 2010 election.
