The report of FEC Form 5 was dated October 2, 2012, and filed on the last day of the reporting period.

The expenditures were made primarily for review and editing of selected essays for posting on a website as well as securing permission to use the material.

I also posted my personal blogs on the website, costs for which were less than \$3,042.24 for editing, typing, supplies, and web site costs.

Of the \$15,523.15 spent in the period, \$12,480.91 was attributable to the essays. Another \$750.00 was spent on typing, partly for the essays and partly for blogs (breakdown not determinable).

All essays for which expenses were incurred and reported during the period were disseminated after October 2, 2012.
