The contributions listed in your letter as contributor name Mrs. Kevin E Gibbs were correctly disclosed as contributions from Mr. Kevin R Gibbs and Mrs. Kevin E Gibbs, two individuals who each contributed \$2,700 toward General 2018 on 7/16/2018.

The contributions listed in your letter for contributor name James K Harris omitted a refund disclosed on the October Quarterly report, Schedule B, Line 20A of \$200 on 9/30/2018.

The contributions listed in your letter for contributor name Shauna Riddle Thies omitted a refund disclosed on the October Quarterly report, Schedule B, Line 20A of \$350 on 9/14/2018.

The Commission has requested clarification on Schedule A of our report on contributions received from political committees not registered with the Commission. Upon receiving a contribution from an unregistered organization, the Committee sends a letter to the donor informing them of the law relative to unregistered committees and requesting verification that the contribution was made with federally permissible funds. As referenced in the committee statement of organization, one of the joint fundraising participants is a non-federal committee. Any contribution deemed impermissible under federal law, but permissible under state law, is allocated in full to the state joint fundraising participant. If the Committee determines that the contribution is impermissible, a refund is issued within 30 days of this determination. Letters were sent to the following unregistered organizations:

- Blaine County Republican Central Committee: Committee is awaiting letter to be returned
- Beaverhead County Republican Committee: Letter returned, funds permissible
- Lewis & Clark Co. Republican Committee: Committee is awaiting letter to be returned
- MCA BuckPAC: Letter returned, funds permissible
- Madison County Republican Party: Committee is awaiting letter to be returned
- Prairie Co Republican Women: Letter returned, funds permissible
- Ravalli Co Republican Women's Club: Committee is awaiting letter to be returned
- Rosebud County Republican Women's Club: Letter returned, funds permissible

2. Due to a data entry error, the rent payment to John C. Taylor Trust was reported on Schedule B, Line 20A instead of Schedule B, Line 17. The Committee has filed an Amended October Quarterly report to correct this error.

3. The committee has filed an amended Statement of Organization disclosing Rosendale Majority Committee as joint fundraising representative.
