On Noember 8, I went to the Midwest WUst City Post office
idwest CityMOK and returned fromthere after mailing my items to my own
ersonal mail box on the grounds of the apartment complex where I

There were three men two with leaf blowers working about thrity feet away
as I cam up the walkway to the Post office box that is mine as I got my key and opened
he box, I was sparedw ith dusk grit, tiny rocks and leaf @ debeis. One of the
men with a leaf blower came up on one side of me and
the otheron the other side with hisleaf blower operating and sprayed be both
f the from both sides incuding my face, eyesi et.

I couold understand this being an accident if one person had been involed but to have o
weld with a supervisor present who was suposed to watch t-hem, I find it
nlickly this was an accident. Apercsone running for office can get few potes
if he is blind.

I contact-ed t-he Midwest City eepartment andthey said as far as they could determine
t was an accident hence they do not plan to do anything abut it and I can not findout
he names of the poeple involed or the compnay theyworked for. Thhis id descibed int he copie
fo information and report sent to the Midwest Polic Dept and to the Attorney Gernal of
Oklahoma, the latt-er has not replied to my letter yet.

I am inclsing copies of the photos of turck involed used by the thre e men and appeared
o be their comnay turck and Iwas otld theyworked for a contractor who name they would not
ie to me so if gt was an accident why all the secrecy in the matter. However if I was attack
because of my polical activity that is a completely other
atterm I am of the opinion I need some protection from theFBI, the sEcret SErvice
or other agency like the Marshalls service of the US initially in this matter and for
prt-ection until I am better reconized and publicised as a candidate.
