GOPAC, Inc. has not made contributions to federal candidates during this reporting period and has no plans to make such contributions at any time during the future. GOPAC has determined to focus its efforts exclusively on state and local Republican campaign activities. Such focus has historically been, and continues to be, the primary purpose of GOPAC, Inc.

GOPAC, Inc. is hereby terminating its federal account and is transferring the cash balance of \$2,370.26 to the Organization's non-federal account.

You will also note there are no outstanding debts or obligations owed to or by GOPAC, Inc.'s federal account. The federal share of all outstanding debts and obligations was fully paid prior to December 31, 1999.

This concludes the FEC reporting requirements for GOPAC, Inc. Please be advised that GOPAC, Inc. will voluntarily continue to make the names and addresses of donors to its non-federal accounts available to the media and the public.
