
Dear Mr. Ciaraldi:

I am in receipt of and thank you for your letter of August 29, 2000 concerning the Commission's preliminary review of the report(s) referenced above.

Upon review of our records, we have noted two reporting errors due to clerical error regarding information in the above referenced report. Schedule B of the July Monthly report incorrectly reported the election period for contributions to Ensign for Senate and Lazio 2000 in the "Disbursement for:" section, designating the contributions to the primary rather than the correct General Election period. Although the correct period was stated in the description of the purpose of the disbursement, an "x" was incorrectly placed in the primary box. I have enclosed a revised Schedule B which correctly reflects the election periods for which these two contributions were designated.
