The policy is as follows: 1) All solicitations include a clear and conspicuous request for the identification information and the initial request informs the contributor of the committee's obligation to use its best efforts to collect the identification information; 2) If the contributor does not provide the requested information in the initial request the committee makes a follow up phone call (or sends a follow up correspondence with a pre-address response envelop) and asks again for the identification information within thirty (30) days of the contribution. The follow up request again informs the contributor of the requirements of federal law for the reporting of such identification information, and of the committee's obligation to use best efforts to collect the contribution information. If the identification information is not received by the due date of the 3X report, the contributor record include the phrase 'Information Requested.' If and when the information is obtained, the committee will amend its report to disclose the identification information received.
