This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **An adequate response must be received at the Commission by the response date noted above.** An itemization of the information needed follows:

-The totals listed on Lines 6(c), 7, 11(a)(i), 11(a)(ii), 11(a)(iii), 11(b), 11(c), 11(d), 12, 15, 17, 19, 20, 21(a)(i), 21(a)(ii), 21(b), 21(c), 22, 29, 31, and 32, Column B of the Summary and Detailed Summary Page(s) appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B totals. Please amend your report and any subsequent reports that may be affected by this correction.

-The beginning cash balance of this report should equal the ending balance of your Amended August Monthly Report (7/1/05-7/31/05), received 8/28/06. Please clarify this discrepancy and amend any subsequent report(s) that may be affected by this correction.

-Your report discloses an outstanding balance(s) beginning this period for a \$500 debt owed to 21st Century Democrats- Non-Fed Acct and a \$5,068.50 debt owed to Integral Resources. However, an outstanding balance(s) at the close of the period was not disclosed on your Amended August Monthly Report (4/1/05-7/31/05), received 8/28/06. Please amend your report(s) to clarify this discrepancy.

Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. Requests for extensions of time in which to respond will not be considered. Failure to provide an adequate response by this date may result in an audit of the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.
