-Your calculations for Line 29, Column B appear to be incorrect. FEC calculations disclose this amount(s) to be \$240,113. Please provide the corrected total(s) on the Detailed Summary Page.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
