Dear Ms. Taylor:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Line 11(a)(1) of the Detailed Summary Page of your report discloses a total of \$7,150 in contributions from individuals/persons other than political committees. The sum of the entries itemized on Schedule A, however, indicates the total to be \$6,850. Please amend your report to clarify the discrepancy.

-Your calculations for Lines 11(a)(i) through 20 appear to be incorrect. FEC calculations disclose this amount to be \$30,508.86 for Column A and \$49,910.60 for Column B. Please provide the corrected totals on the Detailed Summary Page. In addition, please amend your subsequent report(s) which may be affected by this correction.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
