She was refunded through the partnership \$166.66 on 8/29/12 for an excessive contribution from her partnership. On Oct. 16, she made a personal contribution of \$3000, which brought her aggregate amount of contributions for 2012 to \$4666.67. Through discussions with our FEC analyst, it has come to our attention that the FEC software doesn't automatically pull memo item contributions from line 11A and memo item refunds from line 28A into the aggregating amount for an individual; therefore, we are disclosing here for the public record that Linda Fareed's aggregate contribution to Thoroughbred PAC for 2012 is \$4666.67.
