Dear Mr. Evans:

This letter responds to your RQ-2 dated April 1, 1998. Prior to receipt of your letter, we used memo entries in our March 20 Monthly Report to reflect a change in the noted contribution for Amory Houghton, originally reported in our 1997 Year End Report (7/1/97 - 12/31/97).

In our amended March 20 Monthly Report (2/1/98 - 2/28/98), COREPAC redesignated our original contribution of \$5000 toward Mr. Houghton's Primary to indicate a \$4,000 contribution toward his Primary and a \$1,000 contribution toward his General election. This should bring us and our affiliates into compliance with the contribution limits set forth in USC §441a(a) of \$5,000 per election. Mr. Houghton's campaign has already been notified, and a copy of our report was forwarded to the campaign.
