Dear Ms. Conway:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-The totals listed on Lines 11(a)(iii) and 11(d), Column B of the Detailed Summary Page appear to be incorrect. Please be advised that you should add the "Calendar Year-to-Date" total from your previous report to the current "Total This Period" figure from Column A to derive the correct Column B totals.

-Line 11(a)(i) of the Detailed Summary Page of your report discloses a total of \$155,948.31 in itemized contributions from individuals. The sum of the entries itemized on Schedule A, however, indicates the total to be \$155,848.31. Please amend your report to clarify the discrepancy. Please be advised there appears to be a calculation error on Page 42 of Schedule A.


-Please amend your report by providing the full name and address for each disbursement itemized on Schedule B4 supporting Line 21(a).

-Please clarify all expenditures for "voter registration" and "GOTV". In addition, if any of the voter registration or GOTV activities referenced House or Senate candidates, they should be allocated accordingly, unless merely incidental to the overall activity. If a portion or all of these expenditures were made on behalf of federal candidates, they should be reported on Schedule B or F for Lines 23 or 25 of the Detailed Summary Page, as appropriate.
