Dear Mr. Stoetzer:

This letter is in response to the Commission's request for additional information related to the disclosure of one or more contributions on Schedule A which appear to exceed contribution limits and one or more contributions on Schedule B which also appear to exceed contribution limits.

Regarding the contribution on Schedule A, it was noted on the 2011 Year-End report that the refund to Physician & Investors LLC would appear on the next subsequent report. A refund for the full amount of the contribution was issued on 1/30/2012 and disclosed on the Committee's February Monthly report. A photocopy of the refund check has been sent to the Commission.

Upon review of the contributions on Schedule B the Committee determined that an inadvertent data entry error had been made and a duplicate record for Hatch Election Committee Inc. was created in the Committee's database. This caused the contributions to Hatch Election Committee on 2/24/2011 and 11/30/2011 to be incorrectly designated to the 2012 Primary Election. The recipient committee designated each of these contributions to the 2012 General Election on their reports. We have amended our 2011 Mid-Year and Year-End reports to reflect the correct designations.


