This letter is prompted by the Commission's preliminary review of the report referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. Failure to adequately respond by the response date noted above could result in an audit or enforcement action. Additional information is needed for the following 4 item(s):

1. Your report discloses a loan on Schedule C from "Federal Election Commission-LOAN MADE," which has not been recorded on Schedule A. Loans and loan repayments received must be reflected on Schedule A as well as on Schedule C. Please amend your report to clarify this discrepancy. (52 U.S.C. \$30104(b)(3)(E) and (5)(D))

2. Commission Regulations require the continuous reporting of all outstanding loans. This report omits the loan(s) itemized on your previous report(s). Please amend your report(s) to indicate the current status of the following loan(s): "Intuit." (11 CFR §§ 104.3(d) and 104.11)

3. Schedule D of your report itemizes debt owed to "Carone, Rafaello Mr." with an outstanding beginning balance(s) not included on your previous report. Please file an amendment to your report(s) to correct this discrepancy. (11 CFR § 104.11(b))

4. Schedule D of your report discloses the purpose for a debt owed by "Federal Election Commission" to be "Loan". Please be advised that all loans received should be properly disclosed on a Schedule C. Please disclose this activity on the appropriate schedule or provide clarifying information regarding the nature of this debt.

Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses must be received by the Commission on or before the due date noted above to be taken into consideration in determining whether audit action will be initiated. Failure to comply with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action. Requests for extensions of time in which to respond will not be considered.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
