Dear Mr. Coleman:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. This notice requests information essential to full public disclosure of your federal election campaign finances. **An adequate response must be received at the Commission by the response date noted above.** An itemization of the information needed follows:

-Schedule D supporting Line 10 discloses several debts owed to "NYS Laborers' Health and Safety Trust Fund" and "NYS LECET" with negative beginning and ending balances totaling \$-242,206.41, respectively (see attached). Be advised that the use of negative entries on Schedule D for Line 10 suggests that you have either made a mathematical error or overpaid the debt(s), which would result in the creditor incurring a debt owed to your committee and should be reported on Schedule D supporting Line 9 of your report. Properly reporting your debt payments as positive entries would clarify for the public record the total amount of debt payments actually disbursed, the amount of debts actually owed by your committee, and more accurately reflect your committee's cash-on-hand amount.

Please amend your report to properly disclose this activity and clarify the use of negative entries on Schedule D.


Please note, you will not receive an additional notice from the Commission on this matter. Adequate responses received on or before this date will be taken into consideration in determining whether audit action will be initiated. **Requests for extensions of time in which to respond will not be considered.** Failure to provide an adequate response by this date may result in an audit of the committee. Failure to comply

with the provisions of the Act may also result in an enforcement action against the committee. Any response submitted by your committee will be placed on the public record and will be considered by the Commission prior to taking enforcement action.

Electronic filers must file amendments (to include statements, designations and reports) in an electronic format and must submit an amended report in its entirety, rather than just those portions of the report that are being amended.
