On April 7, 2008, the committee received two invoices from The Monaco Group for printing services. The committee paid both invoices on April 16, 2008, as reported in its May 20 Monthly FEC Form 3X report. The committee subsequently discovered that one of the two invoices (Invoice No. 18409, \$784.21) should have been sent by The Monaco Group to another organization for payment. The committee contacted The Monaco Group regarding this error, and The Monaco Group sent a refund check to the committee for \$784.21, which the committee received on May 13, 2008.
