

¹ In the example documents provided in our October 8 packet, the totals on Line 32 of the Detailed Summary Page wrongly indicated \$0.00 for both the periodic and year-to-date "Total Federal Disbursements". In this formal amended filing, Line 32 has been corrected to reflect the fact that there were \$678.50 in both periodic and year-to-date "Total Federal Disbursements" as of the end of the first calendar quarter.
