
We also understand that an Amendment to the Statement of Organization needs to be completed by the new PAC Treasurer. Brian Raber is the President of MAPPS and can be reached at:

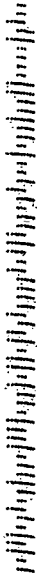
