Dear Mr. Maxwell:

This letter provides an additional response to the Commission's preliminary review of the report referenced above.

Schedule B supporting Line 23 disclosed a contribution that appears to exceed the limits set forth in 2 U.S.C. § 441a(a) which precludes a multicandidate committee and its affiliates from making a contribution to a candidate for federal office in excess of \$5,000 per election. This issue was raised based upon a contribution of \$4,000 that the ARAMARK PAC made to "Santorum 2000" on September 19, 1997. This contribution was reported, in error, as a contribution to "1997 General" election. A review of our records indicates the contribution was requested by an ARAMARK PAC member in response to an invitation to an April 2000 Primary fund-raising event. It was our intent to make a \$4,000 contribution to the April 2000 Primary, and it should have been designated as such on the 1997 Year-End Report (07/01/1997-12/31/1997).

Enclosed is an Amended 1997 Year-End Report (07/01/1997-12/31/1997) Report (FEC Form 3X and Schedule B-Supporting Line 23) that corrects the election designation.

It was our intent to make a \$5,000 contribution to the 2000 General Election that was erroneously reported on the 30-Day Post-General Report (10/19/00-11/27/00).

In view of the above, we have rescinded our request for a refund from "Santorum 2000". For future reporting purposes, we will make every effort to designate the appropriate election for each contribution.
