With regard to your letter dated August 7, 2002, ASPAC retains a law firm to administer the PAC. The firm's services include record-keeping, check writing, and preparation of the FEC reports. So the retainer includes those normal administrative expenses to which you refer. Also, because all the record-keeping is done by the law firm, the PAC does not need an office. The PAC is usually billed quarterly, however, the billing process is not consistent.
