Dear Mr. Lundquist:

This letter is prompted by the Commission's preliminary review of the report(s) referenced above. The review raised questions concerning certain information contained in the report(s). An itemization follows:

-Schedule B of your report discloses a payment to your connected organization for the use of an airplane resulting in an in-kind contribution to a candidate (pertinent portion attached). 2 U.S.C. \$441b prohibits a corporation or labor organization from contributing or expending funds for the purpose of influencing any federal election; however, a committee may prepay its connected organization for the cost of using facilities for events which result in in-kind contributions to candidates. Alternatively, a committee may place funds in escrow for the connected organization to draw on to pay for future in-kind contributions made by the committee.

Please amend your report to clarify whether the payment to your connected organization was for expenditures which were intended to influence federal elections and provide the dates of the activity conducted by your connected organization. Although the Commission may take further legal steps concerning this matter, your prompt action will be taken into consideration.

A written response or an amendment to your original report(s) correcting the above problem(s) should be filed with the Federal Election Commission within fifteen (15) days of the date of this letter.
