Each reporting period, WAVE PAC has been calculating the allocated administrative expenses between the contributions account and the IE account. The bank accounts for each remain segregated. The contributions account has been the primary payor to vendors for allocable administrative expenses. For the semi-annual 2019 reporting period, the IE account's allocated portion of administrative expenses that will be transferred to the contribution account's bank account totals \$10,196.98. Funds will be transferred in January 2020.
